**NOTICE OF CIRCUIT JUDGE VACANCY  
FIRST JUDICIAL CIRCUIT (At Large)**

Please take notice that a vacancy will exist in the office of Circuit Judge At Large of the First Judicial Circuit of Illinois by reason of the election of Judge James R. Moore to the Fifth District Appellate Court upon his taking that office effective December 5, 2016.

Pursuant to the authority of section 12, subsection (c) of article VI of the Constitution of Illinois, the Supreme Court will appoint a person to temporarily fill that vacancy until the vacancy is filled through the general election on November 6, 2018. The temporary appointment will terminate December 3, 2018. To be eligible for appointment to fill this vacancy a person must be a resident of First Judicial Circuit at the time of the appointment.

Qualifications for the office of Circuit Judge are set forth in section 11 of article VI of the Constitution of Illinois and 705 ILCS 40/2(d). Persons meeting those qualifications are invited to submit applications containing the information requested in the Applicant Information for Circuit Judge At Large, First Judicial Circuit Vacancy along with a cover letter to Chief Justice Lloyd A. Karmeier, P.O. Box 266, Nashville, IL 62263 or submitted electronically to his Judicial Secretary, Carol Heggemeier at [cheggemeier@illinoiscourts.gov](mailto:cheggemeier@illinoiscourts.gov). Applications must be received in his office by Wednesday, November 30, 2016.
