Statement of Purpose:

To advise the Judicial Conference in matters affecting criminal justice.

General Charge:

The Committee shall review and make recommendations on matters affecting criminal justice. The Committee will review, analyze and examine new issues arising out of legislation and case law that impact criminal law and procedures and any aspect of criminal justice.

Conference Year 2014 Projects/Priorities:

- Address concerns about the use of video conference technology in criminal cases.
- Address concerns about whether Supreme Court Rule 402(d) should be amended to address ineffective assistance of counsel claims based on the 2012 United States Supreme Court decisions in *Missouri v. Frye* and *Lafler v. Cooper*.
- Study, examine and report on Supreme Court Rules as they relate to criminal procedure and court processes.
- Undertake any such other projects or initiatives that are consistent with the Committee charge.
