The Supreme Court having determined that the  
public necessity so requires;

Effective February 3, 2014, and terminating  
December 5, 2016, the Honorable Bertina E.  
Lampkin, Judge of the Circuit Court of Cook  
County, is reassigned to duty in the Appellate  
Court, First District, to the vacancy created by  
the death of the Honorable Patrick J. Quinn.  
Judge Lampkin shall retain her current rotation  
in the Sixth Division and continue with her  
current case assignments.

During such service on the Appellate Court, Judge  
Lampkin is relieved from all her regular duties  
in the Circuit Court of Cook County, and she  
shall receive compensation for such active  
service at the rate normally paid Appellate  
Judges of the State of Illinois.

Effective February 3, 2014, and terminating December 5, 2016, the Honorable Laura C. Liu, Judge of the Circuit Court of Cook County, is assigned to duty in the Appellate Court, First District, to the position currently held by the Honorable Bertina E. Judge Liu shall occupy the rotation position, in the Second Division, formerly held by the Honorable Patrick J. Quinn, and Judge Liu shall be assigned the cases of Judge Quinn upon her taking office.

During such service on the Appellate Court, Judge Liu is relieved from all her regular duties in the Circuit Court of Cook County, and she shall receive compensation for such active service at the rate normally paid Appellate Judges of the State of Illinois.
