M.R.028655 - In re: Richard Carl Moenning. Disciplinary Commission.

Petition by the Administrator of the Attorney Registration and Disciplinary Commission for order and judgment for costs pursuant to Supreme Court Rule 773. Allowed. Costs in the amount of \$1,000 are assessed against Richard Carl Moenning, and he is directed to pay the costs in full to the Attorney Registration and Disciplinary Commission within thirty (30) days of the entry of this order.

Judgment in the amount of \$1,000 is entered for the Attorney Registration and Disciplinary Commission and against Richard Carl Moenning.
