ADMINISTRATOR’S MOTION TO SUPPLEMENT PETITION FOR INTERIM SUSPENSION PURSUANT TO SUPREME COURT RULE 774(a)(2)

Jerome Larkin, Administrator of the Attorney Registration and Disciplinary Commission, by his attorneys, Wendy J. Muchman and Shelley M. Bethune, moves to supplement his Petition for Interim Suspension Pursuant to Supreme Court Rule 774(a)(2). In support, the Administrator states:

1. On October 13, 2016, the Administrator filed with this Court, a Petition for Interim Suspension Pursuant to Supreme Court Rule 774(a)(2) (the “Petition”) in this matter. The Petition had 15 exhibits. On October 13, 2016, Petitioner accepted personal service of the Petition.

2. Supreme Court Rule 774(a)(2) provides in pertinent part that “[D]uring the pendency of a criminal indictment, criminal information...” the Administrator may petition the Court for a suspension until further order of court.

3. On October 20, 2016, Respondent was indicted in the Circuit Court of Cook County on charges of Official Misconduct, in violation of 720 ILCS 5/33-3(a)(2), a class 3 felony, and False Personation, in violation of 720 ILCS 5/17-2(b)(92), a class A misdemeanor.

4. Based upon the language of Supreme Court Rule 774(a)(2) the indictment is relevant information for this Court, providing further support for the order for rule to show cause






